The development of the cancer center plan continues to move forward as we work with physician partners, developers, municipalities and healthcare governing bodies from both a programmatic and a facilities perspective. It will be beautifully located in Schaumburg, on the former Motorola campus, visible and accessible from Interstate 90. The current timeline estimates state and healthcare approvals mid to late summer with groundbreaking in fall 2022. We anticipate our first patients in the new center in late spring 2024. "This year I transitioned into a new position as the Director of Neurosciences Services. In this position, one of the areas I work with is stroke. When I was in high school, my grandmother died of a stroke. She was in India and after experiencing symptoms in a small village, she was taken on a slow tractor to the nearest hospital which then took hours to get to, and by then was paralyzed. Working at NCH, where we can get immediate and high quality treatment for patients in our community having strokes is a blessing from above. I wanted to give back as a honor to my grandmother, and in hope that nobody I know has to go through an experience like that again.



This year I also had the honor of serving as one of the coordinators of our COVID command center and vaccine clinic. I am so inspired by all the staff who came together and simply stepped up in every way possible. I'm also donating to thank and support every single person I know still putting in tremendous time and effort to support our patients.

I am so proud to work at NCH for so many reasons. I've been in healthcare for 20+ years and I have never felt so strongly that my colleagues here are my family. Maybe it's because of our bond through COVID, maybe it's the culture, maybe it's the community. It's likely a combination of everything.

In a time when patients have so many choices – going to so many different types of providers in the market – I really hope that the culture of having a hospital and this family as a focal point of the community stays intact. My donation is a small part of keeping this concept alive.”



2021 GOLF CLASSIC RAISES A RECORD \$540,000

Northwest Community Hospital Foundation's 24th annual Golf Classic at Medinah Country Club on July 26, 2021 raised more than \$540,000 in net proceeds, far surpassing previous fundraising records for this longstanding event. Funds from the outing are supporting an ambitious plan to transform cancer care for the region. MedProperties was the Title Sponsor of the 2021 event that also included an online silent auction and raffle that garnered support from attendees as well as members of the community. The Golf Classic has raised nearly \$12 million in gross revenue in its 24-year history.


